ELECTION NOTICE - E2025/27
Stages 1 and 2

Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

Stage 1

- Federal Executive Members (8)

Stage 2

- Federal President (1)
- Federal Vice President (2)
- Federal Treasurer (1)

STAGE 1

Nominations will open at 1:30pm Australian Eastern Standard Time (AEST) on Wednesday 3 September 2025, at the Annual Federal Council meeting taking place at Hyatt Hotel, 120 Commonwealth Avenue, Canberra. **Completed Nomination Forms** are to be handed to the Returning Officer at the Annual Federal Council meeting. The Returning Officer will advise the closing time of nominations at the meeting.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Scrutineer Appointment

Scrutineer appointment closes before nominations close at the meeting.

Voting at the Annual Federal Council meeting

The attendance ballot, if required, will open and close at the Annual Federal Council meeting following the nomination close with the time to be advised by the Returning Officer.

Absent Voting

Any eligible member who is unable to attend the meeting shall, upon written application being made by him to the Returning Officer by 12:00 noon AEST on 2 September 2025 may apply for a postal vote. The postal ballot, if required will open on 5/09/2025 and close at 10:00am Australian Eastern Standard Time (AEST) on 3/10/2025.

If stage 1 ballot count is completed at the Annual Federal Council meeting, the Returning Officer will proceed to conduct stage 2 of the election at the same meeting.

STAGE 2

Nominations, which must be in writing and comply with the registered rules of the Organisation, will open and close at the Annual Federal Council meeting at a time to be advised by the Returning Officer after completing the election of Federal Executive Members. **Completed Nomination Forms** are to be handed to the Returning Officer at the Annual Federal Council meeting.

Scrutineer Appointment

Scrutineer appointment closes before nominations close at the meeting.

Voting at the Annual Federal Council meeting

The attendance ballot, if required, will open and close at the Annual Federal Council meeting following the nomination close for stage 2, with the time to be advised by the Returning Officer.

If the stage 1 election is not completed on 3 September due to an absent vote application, an election notice for the stage 2 election will be provided.
