Fair Work (Registered Organisations) Act 2009 s.159—Alteration of other rules of organisation

#### Police Federation of Australia

Alteration of other rules of organisation.

- [1] On 1 September 2025 the Northern Territory Police Branch (the Branch) of the Police Federation of Australia (the PFA) lodged with the Fair Work Commission (the Commission) a notice and declaration setting out particulars of alterations to its rules. Further materials in support of the alterations were lodged on 29 September 2025.
- [2] The Branch seeks certification of the alterations under section 159 of the Fair Work (Registered Organisations) Act 2009 (the Act).
- [3] On the information contained in the notice and declarations, I am satisfied the alterations have been made under the rules of the organisation.
- [4] The particulars of the alterations seek to insert a new subrule 52DO(11)(f) in Part CD of the PFA rules.
- [5] The alteration seeks to address findings raised by the Australian Electoral Commission (AEC) in a post-election report which highlighted an issue in relation to a scheduled election held in 2024. The AEC noted that subrule 52DO(11) does not appear to indicate a voting system for the election of Branch Executive members.<sup>1</sup>
- [6] The proposed insertion of new subrule 52DO(11)(f) into the PFA rules specifies that '[t]he system of voting in any election conducted under this rule shall be the first past the post system'. This is an appropriate response to the matter raised by the AEC.
- [7] The alteration is minor and uncontroversial. It does not require comment beyond expressing my opinion about the matters set out in subsection 159(1) of the Act.

[8] In my opinion, the alterations comply with and are not contrary to the Act, the *Fair Work Act 2009*, modern awards and enterprise agreements, are not otherwise contrary to law and were made under the rules of the organisation. I certify accordingly under subsection 159(1) of the Act.
